**NOTICE OF INTENT TO ACT UPON A REGULATION
LCB File No. R063-16**

**Notice of Hearing for the Adoption of Regulations of the
State of Nevada Board of Examiners for Alcohol, Drug and Gambling Counselors**

The State of Nevada Board of Examiners for Alcohol, Drug and Gambling Counselors will hold a public hearing at 9:30 a.m., on the 12th day of August 2016, at Truckee Meadows Community College, Redfield Campus, 18600 Wedge Parkway, Building B, Room 102, Reno, Nevada 89511, with video conferencing to University of Las Vegas, 4505 Maryland Parkway, System Computing Services Building, Room 102, Las Vegas, Nevada 89154. The purpose of the hearing is to receive comments from all interested persons regarding the adoption of regulations that pertain to chapter 641C of the Nevada Administrative Code (LCB File No. R063-16).

The following information is provided pursuant to the requirements of NRS 233B.0603:

1. This regulation is needed to provide a definition as to what is meant by the term "treatment agency."
2. This regulation is not a temporary regulation.
3. This is a permanent regulation and a copy of the regulation may be obtained by contacting Agata Gawronski, Executive Director of the Nevada State Board of Examiners for Alcohol, Drug and Gambling Counselors, 400 W. King Street, Suite 111, Carson City, NV 89703, 775-684-7080, agawronski@adgc.nv.gov.
4. There are no adverse effects of this regulation on the businesses it regulates nor on the public. The beneficial effects are that the industry will be able to know what the Board means by the term "treatment agency." This will insure that the industry remains compliant with the places that a certified intern may practice. The immediate

and long-term effects are that the industry will be able to understand the locations that a certified intern may practice.

5. The Board staff reviewed the regulation with its legal counsel and determined that the addition of a definition for the term “treatment agency” would not impact a small business.
6. There is no cost to the Board for enforcement of this regulation.
7. There are no other state or local governmental agencies which this regulation overlaps or duplicates.
8. This regulation is not required pursuant to a federal law.
9. This regulation does not contain any provisions which are more stringent than a federal regulation that regulates the same activity.
10. This regulation does not establish a new fee nor increases an existing fee.
11. This regulation is not a temporary regulation.

Persons wishing to comment upon the proposed action of the Nevada State Board of Examiners for Alcohol, Drug and Gambling Counselors may appear at the scheduled public hearing or may address their comments, data, views or arguments, in written form, to Agata Gawronski, Executive Director of the Nevada State Board of Examiners for Alcohol, Drug and Gambling Counselors, 400 W. Written submissions must be received by the Nevada State Board of Examiners for Alcohol, Drug and Gambling Counselors on or before August 10, 2016. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Nevada State Board of Examiners for Alcohol, Drug and Gambling Counselors may proceed immediately to act upon any written submissions.

A copy of this notice and the regulation (LCB File No. R063-16) to be adopted will be on file at the State Library, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. Additional copies of the notice and the regulation (LCB File No. R063-16) to be adopted will be available at Nevada State Board of Examiners for Alcohol, Drug and Gambling Counselors, 400 W. King Street, Suite 111, Carson City, NV 89703, and the Board’s website at <http://alcohol.nv.gov/> and in all counties in which an office of the agency is not maintained, at the main public library, for inspection and copying by members of the public during business hours. Copies of this notice and the proposed regulation will also be mailed to members of the public at no charge upon request.

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter, shall issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.
