#### Item 3: Review of proposed changes to the NRS 641C (for possible action)

Agata Gawronski stated that previously we proposed to remove NRS 641C.130 but have re-reviewed and decided to keep.

NRS 641C.420 specific to CADC Internship

NRS 641C.420 Replacing enrolled in program to: Required Associates degree or 60 credits towards Bachelors degree, to include: a minimum of 18 credits in addiction specific studies.

Subsection: AA degree or 60 credits towards BS or BA to include 18 credits in addiction specific studies.

Removing section C: Requirement for proof of high school diploma or GED, if the person has an associate's degree or higher.

NRS 641C.530 Reports of Criminal History: Add subsection:

All applicants with past felony charges must be reviewed by the board prior to approval.

All violent offences and/or sexual related offences based upon original charge must be reviewed unless found not guilty.

NRS 641C.250 License or certificate issued pursuant to the provision of this chapter

NRS 641C.500 Certification of the Detoxification Technician: Removing all of 641C.500 from NAC

NRS.641C.250.2B Need to remove the phrase without limitation. 641C2B #1 making a diagnosis with the exception of psychotic disorders.

Agata Gawronski stated that in January 31 meeting, Barry Lovgren brought up the question of those facilities not funded by SAPTA are practicing without following regulations.

Steve stated that we need to pursue defining us (Board of Examiners for Alcohol, Drug and Gambling Counselors) as healthcare providers. NRS 629.031 Propose adding our number 641C to the list in the pursuant section.

NRS 641C.200.830 Performance of healthcare procedure without licensure. Barb stated that the only one she had looked at was 205.330 fraud with impersonation.

# Item 4: Review of the proposed changes to NAC 641C (for possible action)

NAC 641C.200 Application for license or certificate: Need to add two subsection to reflect additions to NRS 641C.420 i.e. (AA degree or 60 credits towards BS or BA to include 18 credits in addiction specific studies).

Fingerprints reviewed every two years.

NAC 641C.205 Cleaned up the language.

Keeping supervisors training as required by the board

Steve Burt stated that we would write in the new certification and submit to LCB allowing LCB to figure out what regulation number would be assigned.

Agata Gawronski will submit the packet to LCB instruction to assign a new number for the Peer Recovery Specialist.

Steve Burt provided a different set of ethics from IC&RC that are used for this type of certification.

Agata Gawronski asked if anyone had additions or changes. If not she was going to proceed to prepare for approval and submission to LCB
