The Board of Examiners for Alcohol and Drug Counselors, 400 King Street, Suite #111 Carson City, Nevada 89703, is proposing the Adoption, Amendment and or /Repeal of regulations pertaining to chapter 641C of the Nevada Revised Statues. **A workshop has been set for 11 am, on Friday, October 17, 2014 at the Ridge House, 900 W. First Street, Reno, Nevada 89503.** The purpose of the workshop is to solicit comments from interested persons on the proposed regulations:
