1. CLINICAL DIRECTOR – Definition and Essential Duties

This position will provide clinical oversight for TDMRs treatment programs and counseling staff. This is a full-time position (40 hours per week) located in Reno, Nevada. Work responsibilities will include monitoring and evaluating the performance of treatment staff, clinical consultation with case managers and treatment providers, and conducting clinical trainings for counseling staff. This position reports to the Executive Director.

QUALIFICATIONS

A successful candidate must:

- Have proficient knowledge of DSM 5 and ICD 10
- Have the ability to diagnose substance use and mental health disorders
- Be proficient with ASAM levels of care
- Have a good understanding of psychopharmacology
- Have a current license as a clinical social worker, marriage and family therapist, clinical professional counselor or clinical alcohol and drug counselor
- Have at least 3 years' experience providing behavioral health services
- Have at least 1 year of supervisory experience

2. CLINICAL THERAPIST – Definition and essential duties

This position will provide biopsychosocial assessments, one-on-one, and group counseling services to clients with substance use and co-occurring mental health disorders. This position will actively

collaborate with the behavioral health team members and report to the Clinical Director. This is a part-time position which could develop into full-time.

QUALIFICATIONS

A successful candidate must:

- Have proficient knowledge of DSM 5 and ICD 10
- Have the ability to diagnose substance use and mental health disorders
- Be proficient with ASAM levels of care
- Have a good understanding of psychopharmacology
- Have a current license (or be a licensed/certified intern) as a clinical social worker, marriage and family therapist, clinical professional counselor or clinical alcohol and drug counselor
- Have at least 2 years' experience providing behavioral health services

3. SUBSTANCE USE DISORDER COUNSELOR – Definition and Essential Duties

This position will provide assessments, one-on-one and group counseling services to clients with substance use disorders. The counselor will work cooperatively with the treatment team, community stakeholders, and referral sources to coordinate services for clients. This position reports to the clinical director. This is a part-time position which could develop into full-time.

- Have proficient knowledge of DSM 5 and ICD 10
- Have the ability to diagnose substance use and mental health disorders
- Be proficient with ASAM levels of care
- Have a good understanding of psychopharmacology
